**Explanation of Responses:**

- Each Restricted Stock Unit ("RSU") represents a contingent right to receive one share of common stock upon satisfaction of the vesting conditions.
- These are time-based RSUs that will vest, subject to satisfaction of vesting conditions including a continuous business relationship, in three annual installments on June 14, 2024 (25%), June 14, 2025 (25%) and June 14, 2026 (50%).
- Of the total number of RSUs, 1,252 RSUs will vest on March 19, 2024; 932 RSUs will vest on March 18, 2024, and 1,864 RSUs will vest on March 18, 2025; 2,321 RSUs will vest on June 14, 2024, 2,322 RSUs will vest on June 14, 2025, and 4,643 RSUs will vest on June 14, 2026, subject in each case to the satisfaction of vesting conditions, including maintaining a continuous business relationship.
