- Of the total number of RSUs, 10,729 RSUs will vest on March 25, 2022; 9,381 RSUs will vest on March 19, 2022, and 18,764 RSUs will vest on March 19, 2023; 3,915 RSUs will vest on March 19, 2022, 3,916 RSUs will vest on March 19, 2023, and 7,832 RSUs will vest on March 19, 2024; subject in each case to the satisfaction of vesting conditions, including as applicable, continued employment or a continuous business relationship.
